HP BULLETIN 195 ADDENDUM

March 12, 2021

RE: HP Bulletin 195 – Athlete Assistance Program Carding Criteria

This addendum is to further outline the process of nomination for the 2021-2022 Athlete Assistance Program (AAP) indicated in High Performance Bulletin 195, Section 1.

Athletes will be eligible for nomination in June 2021 in the following order of priority:

Priority 1: Athletes who have met the carding criteria as outlined in HP Bulletin 195 will be eligible for nomination for the full 2021-2022 carding cycle and in the following order of priority.

Priority 1A: Athletes who have met the Senior International card criteria (Section 4.8)

Priority 1B: Athletes who have met the Senior National card criteria (Section 4.9)

Priority 1C: Athletes who have met the Development card criteria (Section 4.10)

Priority 2: Remaining athletes (after Priority 1 nominations above) who are currently carded will be eligible to maintain their current carding status until the 2021 Canadian Long Track Championships in October 2021 and will be eligible for nomination for a 4-month card (July – October 2021). Athletes will be required to meet the criteria outlined below (Priority 3) to maintain their current carding and be re-nominated for the remainder of the 2021-2022 carding cycle after the 2021 Canadian Long Track Championships.

Athletes will be nominated for Senior International or Senior National cards after the 2021 Canadian Long Track Championships for the remainder of the 2021-2022 carding cycle in the following order of priority and according to the number of available cards:

Priority 3: Current 2020-2021 National and NextGen Team athletes with a 4-month (July – October 2021) Senior International or Senior National Card who finish in the Top 4 in an Individual Distance at the 2021 Canadian Long Track Championships in October.

Any remaining carding quota will be used to nominate athletes for Development cards after the 2021 Canadian Long Track Championships according to the criteria outlined in HP Bulletin 195 Section 4.10 and will be nominated in the following order of priority:

Priority 4: Any remaining card quota may be used to nominate athletes who have been selected to the “NextGen” Program (if applicable under the carding quota) after the 2021 Canadian Long Track Championships and prioritized in order of rank, and according to the number of available cards.

Priority 5: Any remaining card quota may be used to nominate athletes selected to the National Team Training Partners Pool (if applicable under the card quota). Training Partners may be eligible for up to 4 months of development carding support based on the number of available cards.
